## ARTICLE NO. 2

**Membership** of the PFBA shall remain open to all business entities and residents in Pakistan in the following categories:

(a) Corporate Members: This category shall comprise of French Companies and Pakistan -France Joint Venture Companies duly registered with the Securities & Exchange Commission of Pakistan and/or the State Bank of Pakistan. Each such member, through its representative, shall have the right to vote at general meetings and stand for any office in their category

(b) General Members: This category shall comprise of authorized agents of French Companies. Each such member, through an authorized representative, shall have the right to vote at general meetings and stand for election for any office in their category.

(c) Associate Members: This category shall comprise of trading partners, i.e. importers/exporters of items being trade to France or from France to Pakistan. Each such member shall have right to vote and stand for election for any office in their category
