There will be a round-table conference on the experiences of French companies working in Pakistan with the participation of Dr. Asim Jamal, Managing Director of Sanofi Pakistan and Mr. Abdul Sattar Babar, Managing Director of IPSOS Pakistan. The afternoon session will be reserved for B2B meetings between PFBA delegates and French companies selected by Business France according to the business profile of each delegate. The Embassy of Pakistan in Paris is fully collaborating with this event. We are confident that this Information workshop will meet with great success and will be fruitful for our delegates as well as the French companies they will be meeting. This workshop will further strengthen the already close ties between PFBA and Business France and will certainly lead to a return visit to Pakistan by French companies. We will advise all our members of the outcome of this workshop and its proceedings.

The holy month of Ramadan is drawing to a close. I take this opportunity to wish all our Directors and members a very happy Eid-ul-Fitr. Soon the country will be going to polls for electing a new parliament and provincial assemblies. # PFBA HOSTED A DISCUSSION SESSION WITH MR. SHABBAR ZAIDI AN EMINENT ECONOMIST AND TAX ADVISOR

Pakistan-France Business Alliance organized a discussion session on "The Tax Amnesty Scheme 2018 of Pakistan will be a game changer for Pakistan's Economy" on May 05, 2018 with Mr. Shabbar Zaidi, an Eminent Economist and Tax Advisor and Senior Partner of AF Ferguson.

This brain-storming session was very well attended by PFBA members, businessmen, and bankers. It provided an occasion to the audience to benefit from the assessment of Mr. Shabbar Zaidi of the main Economic and Tax problems facing the country and the type of solutions that people would expect from the new government taken it takes over.

The Deputy Chairman/CEO of PFBA, Mr. Saeed Allawala welcomed Mr. Shabbar Zaidi and gave a brief introduction of Mr. Zaidi. He further highlighted the challenges faced by the country in the economic and tax sectors.

Introducing the topic, the Chairman/CEO of PFBA, Mr. Jamil Hamdani, briefly enumerated the economic and tax issues which are most acutely felt by those who run the industries, banks, and businesses. Among the main issues Mr. Hamdani listed the current account deficit, weak Rupee, insecurity, lack of transparency in public contracts and incompetent economic diplomacy. Mr. Hamdani stressed that people of Pakistan in general and the business community in particular was rightly expecting an economic road-map from the future government.

Mr. Shabbar Zaidi spelt out the economic and tax policy issues which needed urgent attention on the part of the new government. Foremost of which are the current account deficit and the consequent weakening of the Rupee against the convertible foreign currencies, deficit financing, narrow tax base, the circular debt, inconsistent taxation policies, wrong energy mix, inefficient economic governance etc. Mr. Zaidi said that it would be appropriate that the new government issued an economic policy statement along with the next budget. According to him the economic fundamentals of the country were good but when the sea is choppy a strong hand is needed at the Helm of the ship. He reminded the audience that the credit for the economic liberalization reforms and the privatization program goes to the first Nawaz Sharif government which was in power from 1990 to 1993. He cautioned against a short term vision of the things and was of the opinion that after the initial honeymoon which may be of about 100 days, the public opinion will start judging the government on the basis of actual delivery.

After the address of Mr. Shabbar Zaidi, a lively question-answer session ensued in which questions were asked on many issues. During the Q & A sessions, members from the business community highlighted different issues like low tax collection, security problems, slow reform and other major problems that the country has been facing for decades.

At the end Mr. Saeed Allawala, Deputy Chairman/CEO PFBA, thanked the distinguished chief guest for sparing his time for this session and thanked the audience for the keen interest it showed in the discussion.

During their visit to Pakistan they were taken around the country to visit places in the extreme North including Miran Shah, Islamabad, KPK and Baluchistan including Gawadar and Sind. While in Karachi, they visited the likes of the Chamber of Commerce and Industry, the Pakistan Stock Exchange and HUM TV Group. The idea was to invite and let the media personnel see for themselves the changed environment of Pakistan and witness the ground realties which is different from and as incorrectly perceived in the West. A meeting with the visiting delegates was arranged by Pakistan-France Business Alliance on Saturday, January 13 and attended by several members of the PFBA including the Consul General of France in Karachi, Francois Dall'orso. This was done in an effort of appraise them of the changed climate in Pakistan with respect to trade and investments. Chairman / CEO, PFBA, Jamil Hamdani while briefing the delegates informed them about the policies of the government to attract investments and specially with respect to CPEC through which China is investing billions of dollars to improve the infra-structure such as ports, roads and energy. This he said, is setting the stage for foreign investments and it is imperative that French Companies eve Pakistan as a potential destiny for trade and investments. This can be achieved if the media in France portrays Pakistan's potential.

In the interactive session with the visiting members, questions were answered as to specific areas which could be considered, both for trade and for investments. It was followed by a sumptuous dinner for the visiting delegates of the French Media Team.

The main objective and benefit of this event was to conduct a networking session on recent enforcement trends regarding bribery and anti-bribery compliance.

# PFBA CO-HOST NATIONAL SINGLE WINDOW (NSW) AWARENESS SESSION JOINT BUSINESS FOR A BETWEEN PAKISTAN AND OTHER COUNTRIES

The meeting for this purpose had been called on February 13, 2018, at 3:00 PM at the Custom House Auditorium. PFBA along with the other active Bi Lateral Business Forum members attended and take input from the participants as to how the process can be streamlined effectively.

National Single Window (NSW) is being initiated by the Pakistan Customs who recently met us to explain their initiative in order to streamline the procedures involved with imports and exports and also to take our support on how to proceed further.

Pakistan ratified the WTO's Agreement on Trade Facilitation (2013) on 27 October, 2015 and as such has committed herself to the establishment of a 'National Single Window' (NSW) as a 'Category C' commitment with an implementation timeline of five years with effect from 22nd February, 2017. National Single Window is a platform that allows parties involved in trade and transport to lodge standardized information and documents using a single-entry point to fulfill all import, export and transit related regulatory requirements. This reduces cost and time involved in trading across borders while at the same time enhances government's control measures. As part of its trade facilitation and regional trade enhancement agenda, Pakistan is committed to reforming, modernizing, upgrading, and automating its cross-border trade infrastructure.

The Prime Minister's Office vide its directive dated 18th March, 2017 directed the Federal Board of Revenue (FBR) to initiate consultations with the relevant stakeholders for the establishment of the ICT based NSW for cross border trade and designated Pakistan Customs as the Lead Agency keeping in view Customs role and importance in cross-border trade as well as its considerable expertise and experience in designing and implementing trade related automation initiatives. Being cognizant of the importance of stakeholder engagement and collaboration for the success of the NSW initiative, the Prime Minister's Office vide its directive dated 13.10.2017 has desired to establish a 'National Steering Committee (NSC)' at the federal level to oversee the creation of the electronic NSW in the country, and to foster and promote inter-ministerial coordination and participation on NSW related issues.

Accordingly, FBR has initiated consultative process with all stakeholders to develop NSW in a structured manner. Moreover, in line with internationally recommended best practices, a Programme Management Office (PMO) has been established by FBR vide its notification dated 20th October, 2017 that shall be responsible for the design, implementation, and management of the NSW in consultation and coordination with all stakeholders and development partners.


